**PLEASE READ THE FOLLOWING INFORMATION CAREFULLY, & NOTE ADDITIONAL INFORMATION OVERLEAF.**

- There is no restriction on medium or preferred style, for either artist.
- One piece of artwork each, for both the member and junior artist, unless they are smaller 3D items that can be displayed together (max 5 items for jewellery)
- An entry fee of \$10 (inc GST) for RHG members; Junior artist fee: \$5.  
**Total Fee (\$15 for both)** must be submitted with Entry Form.
- **Exhibitors, please note:** Each entry (RHG member & Junior artist):
  - 1) must be no wider than **1 metre (Including frame)**.
  - 2) must have been **recently finished** (*in the past twelve months*)
  - 3) must not have been exhibited in conjunction with Red House or Gallery M before (*including the shop*).
  - 5) must have the correct hanging devices (*see details overleaf*)
  - 6) If framed, frame must have neat backing, new tape etc. Old, chipped or dirty frames are not suitable, and bring down the standard of the entire exhibition.
  - 7) Weight restrictions may apply - any artwork must be able to be moved / hung easily by one person
- **Artworks that do not comply with all of the above guidelines WILL NOT be accepted.**
- **Artwork must be delivered to Gallery M on (or before) Tuesday 4 September between 10am - 4pm** (please bring work in as early as possible) If you are unable to bring work in these times, please make arrangements with Gallery staff to deliver before that date **NO WORK CAN BE ACCEPTED AFTER 4pm TUESDAY 4 SEPTEMBER** Consignment notes and artwork labels will be included in the September mail-out.

## EXHIBITION TERMS AND CONDITIONS

### IMPORTANT DATES

- ◆ **Entry submission:** The Entry Form (lower section overleaf) to be submitted by **31 July 2018**. Lodge entries ASAP to ensure participation.
- ◆ **Delivery of artwork: 10am - 4pm Tuesday 4 September.** If you have any difficulty with the delivery time, contact Gallery M staff to arrange delivery before that date. **Work cannot be accepted after 4pm that day, but can be delivered prior to that date.**
- ◆ **Official opening event: Friday 7 September 2018 (5 - 8pm)** All members and their junior artists are encouraged to attend.
- ◆ **Collection of artwork:** Note: Due to Public Holiday Monday 1 October, extra collection times are: **Sunday 30 September, between 4-6pm; OR Tuesday, 2 October from 9am-12noon.** All work must be collected. No responsibility will be taken for artwork uncollected after that date, unless prior arrangements have been made.

### RIGHT OF REFUSAL

- (a) Gallery M staff have the right to refuse any work.
- (b) Any work that may be considered racist, sexist or offensive may not be accepted.

### COPYRIGHT

- (a) Copyright of all work remains with the originator of the artwork.
- (b) Gallery M reserves the right to document the artworks, maintain a file and utilise images of the artwork for publicity, information or archival purposes.
- (c) Any exhibitor has the sole responsibility for ensuring that their artwork does not infringe another creator's copyright. Artwork that may infringe the cultural property or moral rights of another person or group may not be displayed.

### HANGING AND DISPLAY

- (a) All hanging works must be suitably mounted or framed, with securely fixed hanging cords or wires **attached to D-rings**. The Gallery M hanging system requires hooks to be inserted into the D-rings on either side of the artwork. Screws or lock fittings on metal frames are not suitable. Gallery M had steel D-Rings for sale. **Note: Brass D-rings WILL NOT BE ACCEPTED!**  
**Artwork that does not meet the above hanging requirements will not be accepted.**
- (b) Any display cabinets (provided by exhibitor) must be approved by the Gallery Staff.
- (c) All artwork must be well finished, without sharp edges or rough bases. Any 3-D work should have felt (or similar) on the base

### INSURANCE

It is the Exhibitor's responsibility to insure their own works whilst in transit. All artwork on the premises is insured against Burglary (excluding theft without forcible entry) and Fire only. Maximum claim limits apply. Additional insurance, including Theft, Accidental Breakage or Malicious Damage is the responsibility of the Exhibitor.

### GST

All exhibitors must complete a GST / hobby artist declaration when delivering their artwork (on Exhibition Consignment Note). Exhibition Consignment Notes and artwork labels will be sent to all exhibitors before the exhibition delivery date.

### COMMISSION

A commission of 33% (includes GST) will be taken from the sale price of any sold items.

### PAYMENT FOR SOLD WORKS

Payments are paid directly into the artist's bank account by EFT, if your work is sold you will be asked to provide your account details. Payment for any Junior artwork sold will be paid to the RHG member, to forward on to the Junior artist.
